No meals delivered to theatre
No meals served in dining room after 5.30pm
No dirty dishes from dining room to be washed
No filling up of kitchenette (NO BREAD, NO MILK, NO TEA, NO COFFEE, ETC)
No food store orders

Housekeeping

No cleaning of Non-clinical areas (Offices, Quarter, Private Accommodation)

Plaster Services

No plaster workshops, No in-house training of new medical, clinical staff

Porterage


No Non Patient Handling
